On **February 2, 2012**, at the Pierce County AG Center, 711 Hendry Street, Blackshear, GA., the Georgia Department of Transportation will hold a detour open house concerning Project BRSLB-1825-00(005), Pierce County.

Project BRSLB-1825-00(005), Pierce County is a proposal to replace the existing bridge of substandard load capacity and deck geometry. The roadway shoulders and slopes will be reworked to accommodate bicycles and guardrail. The new bridge will be constructed on the same alignment as the existing bridge. Traffic will be maintained by a 17.5 mile off site detour.

The purpose of this detour open house is to provide the public with an opportunity to view the proposed detour, ask questions, and to provide an opportunity for the public to comment on the proposal.

The detour open house will be conducted between the hours of **4:00 p.m.** and **6:00 p.m.** The meeting will be informal and the public is invited to attend anytime during these hours. There will be no formal presentation.

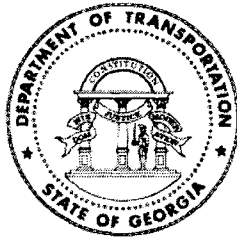


